PAontheweb.com RESELLER / REFERRAL Agreement

An Agreement made this _____ day of _____, 200__ by and between PAontheweb.com, a Pennsylvania business (hereinafter "PAONTHEWEB") and _____, (hereinafter "RESELLER"), an organization wishing to participate in PAontheweb Internet Services RESELLER Program.

WITNESSETH:

WHEREAS, PAONTHEWEB is the provider of the various name brand Internet services, and WHEREAS, RESELLER / REFERRAL Agent is a web design company, advertising agency, sales representative or other service provider desiring authority to resell PAONTHEWEB services, and

WHEREAS, RESELLER / REFERRAL agent desires to take advantage of commissions and discounted services available only to PAONTHEWEB RESELLERS / REFERRAL Agents

NOW THEREFORE, the parties hereto intending to be legally bound hereby agree as follows:

1. This agreement is not term based. Either party may terminate the agreement without cause or reason at any time.
2. RESELLERS / REFERRAL Agents will provide PAONTHEWEB with current contact information including address, phone number(s) and e-mail address and will provide its Employer Identification Number (EIN). Also known as a federal tax identification number, the EIN is used to identify a business entity or SSAN. PAONTHEWEB will provide same information to RESELLER upon request.
3. RESELLERS / REFERRAL Agents will be responsible for closing deals for advertising and web design accounts referred to PAONTHEWEB making sure to (a) enter the customer account using the FAX Form provided by PAONTHEWEB, (b) supply the customer a contact number and PAONTHEWEB approved Terms of Service (TOS) (at the bottom of the Home page on PAontheweb.com), and (c) Verify the customer understands the terms.
4. RESELLERS / REFERRAL Agents should try to refer clients to PAontheweb.com as an advertising resource as well as a web development company. We are currently number 1 for PA Websites. See Google and search PA and or Pennsylvania Websites for current ranking as it does fluctuate.
5. PAONTHEWEB will provide RESELLERS / REFERRAL Agents commissions based on the following:
6. PAONTHEWEB or its assigned representatives will be responsible for all server side technical support after the initial sale and will directly bill customers for Internet related services upon account activation. Credit card billing statements may now reflect our national name LetUsBeYourGuide.com for all billing. Though RESELLERS / REFERRAL Agents may bill customers for associated work outside the PAONTHEWEB system, RESELLERS / REFERRAL Agents is not permitted to bill customers for Internet related services uniquely supplied by PAONTHEWEB.
- 7 An across the board 25% on up front design fees and *25% of all monthly fees of \$49 or more per month will be paid to the RESELLERS / REFERRAL Agents as long as the client remains with *25% on monthly fees will be paid when the RESELLER / REFERRAL Agent has sold or referred 5 clients. The 25% monthly commission will include the 5 websites sold but will NOT be retroactive. PAontheweb.com. Additional programs may come about that pay a higher commission.

8. The parties to this agreement shall remain independent parties and nothing in this agreement shall be deemed to create any other relationship. A 1099 will be sent to all RESELLERS / REFERRAL Agents by 31 Jan of each calendar year when commissions reach the mandatory minimums established by the Federal Government. At this time the minimum requiring a 1099 is \$600 in any calendar year.

9. In the course of implementing this agreement, the parties may become privy to certain confidential information with respect to each other, which information may include customer lists, technology, trade secrets, marketing plans, pricing, budgets, employee salaries, or other sensitive or potentially damaging information. The parties covenant and agree that all such information shall be maintained in the strictest confidence and safeguarded accordingly.
